



## ***REFUND & CANCELLATION POLICY***

A registered participant may cancel on the following dates for the refund amount specified by notifying of withdrawal in writing ([david@greekbibletraveltours.com](mailto:david@greekbibletraveltours.com)). All refunds will be made to the original source of payment and may take up to 3 weeks from the time of notification to process. Refund amounts will be processed according to the following schedule:

Date	Amount Returned
Written notification on or before 120 days prior to start date	100% trip cost (minus \$100 non-refundable booking fee)
Written notification on or before 90 days prior to start date	75% trip cost (minus \$100 non-refundable booking fee)
Written notification on or before 45 days prior to start date	25% trip cost (minus \$100 non-refundable booking fee)
After 44 days prior to start date	0% trip cost

If the trip is subjected to complete cancellation by provider due to venue closures, border closures, or other such imposed restrictions which make the tour infeasible as determined by Logos Journeys Ltd., all refunds will be made to the original source of payment and may take up to 3 weeks from the time of notification to process. Refund amounts will be processed according to the following schedule:

Date	Amount Returned
Written notification on or before 90 days prior to start date	100% trip cost (minus \$100 non-refundable booking fee)
Written notification on or before 60 days prior to start date	75% trip cost (minus \$100 non-refundable booking fee)
Written notification on or before 30 days prior to start date	50% trip cost (minus \$100 non-refundable booking fee)
After 29 days prior to start date	0% trip cost

*In view of the disruptive nature of travel in light of pandemic restrictions, it is recommended that travelers obtain adequate insurance coverage in the event of cancellation by provider.*

Please note that trip prices may include funds collected on behalf of client by Logos Journeys Ltd. DBA Greek Bible Tours for airfare or cruise fare. ## ***RELEASE OF LIABILITY***

**1. AGREEMENT TO FOLLOW DIRECTIONS.** I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by Logos Journeys Ltd. DBA Greek Bible Tours, or the employees, representatives or agents of Logos Journeys Ltd. DBA Greek Bible Tours.

**2. ASSUMPTION OF THE RISKS AND RELEASE.** I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for personal injury to myself and (if applicable) my family members, and further release and discharge Logos Journeys Ltd. DBA Greek Bible Tours for injury, loss or damage arising out of my or my family's use of or presence upon the facilities or services contracted by Logos Journeys Ltd. DBA Greek Bible Tours, whether caused by the fault of myself, my family, Logos Journeys Ltd. DBA Greek Bible Tours or other third parties. I have reviewed current COVID travel restrictions and applicable advisories published by the US Department of State.

**3. INDEMNIFICATION.** I agree to indemnify and defend Logos Journeys Ltd. DBA Greek Bible Tours against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, which may in any way arise from my or my family's use of or presence upon the facilities or services contracted by Logos Journeys Ltd. DBA Greek Bible Tours.

**4. FEES.** I agree to pay for all damages to the facilities contracted by Logos Journeys Ltd. DBA Greek Bible Tours caused by any negligent, reckless, or willful actions by me or my family.

**5. APPLICABLE LAW.** Any legal or equitable claim that may arise from participation in the above shall be resolved under Colorado law.

**6. ARM'S LENGTH AGREEMENT.** This Agreement and each of its terms are the product of an arm's length negotiation between the Parties. In the event any ambiguity is found to exist in the interpretation of this Agreement, or any of its provisions, the Parties, and each of them, explicitly reject the application of any legal or equitable rule of interpretation which would lead to a construction either "for" or "against" a particular party based upon their status as the drafter of a specific term, language, or provision giving rise to such ambiguity.

**7. ENFORCEABILITY.** The invalidity or unenforceability of any provision of this Agreement, whether standing alone or as applied to a particular occurrence or circumstance, shall not affect the validity or enforceability of any other provision of this Agreement or of any other applications of such provision, as the case may be, and such invalid or unenforceable provision shall be deemed not to be a part of this Agreement.

**8. DISPUTE RESOLUTION.** The parties will attempt to resolve any dispute arising out of or relating to this Agreement through friendly negotiations amongst the parties. If the matter is not resolved by negotiation, the parties will resolve the dispute using the below Alternative Dispute Resolution (ADR) procedure.

Any controversies or disputes arising out of or relating to this Agreement will be resolved by binding arbitration under the rules of the American Arbitration Association. The arbitrator's award will be final, and any judgment may be entered upon it by any court having proper jurisdiction.

**9. FORCE MAJEURE.** Logos Journeys Ltd. DBA Greek Bible Tours shall not be liable for any delay or default in performing under this Agreement if such delay or default is caused by conditions beyond its control including, but not limited to acts of God, government restrictions, wars, insurrections and/or any other cause beyond the reasonable control of Logos Journeys Ltd. DBA Greek Bible Tours.

**10. COVID-19.** As the worldwide COVID-19 corona-virus pandemic remains ongoing at this time, I acknowledge that for this reason, and other reasons not reasonably foreseeable at this time, these travel plans may be interrupted or canceled by the supplier that is providing them, a government entity or other third party entity. I acknowledge that Logos Journeys Ltd. DBA Greek Bible Tours may or may not have any input in these cancellations. I further acknowledge that the supplier's own cancellation, re-booking and refund policies, subject to any applicable law that is now or may later be in effect, will govern my rights and remedies, including my right to receive a refund, in such an event. Moreover, I understand that should I elect to purchase travel insurance, the terms of the policy will dictate whether, and to what extent, coverage for any financial loss may exist under the circumstances. By signing below, I hereby agree to hold Logos Journeys Ltd. DBA Greek Bible Tours harmless and release the agency from any and all liability for any damages, including but not limited to monetary losses, I may incur as a result of such interruption or cancellation of these travel plans.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 while traveling. Such exposure or infection may result in personal injury, illness, permanent disability, and possible death. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with Logos Journeys Ltd. DBA Greek Bible Tours. I am aware that the US Department of State may have advised against travel to Greece.

safety measures and precautions which may change from day to day. **11. NO DURESS.** I agree and acknowledge that I am under no pressure or duress to sign this Agreement and that I have been given a reasonable opportunity to review it before signing. I further agree and acknowledge that I am free to have my own legal counsel review this Agreement if I so desire. I further agree and acknowledge that Logos Journeys Ltd. DBA Greek Bible Tours has offered to refund any fees I have heretofore paid to use its contracted facilities or services if I choose not to sign this Agreement. This Agreement contains the entire agreement between the Parties relating to the subject matter thereof. There are no promises, agreements, conditions, undertakings, warranties, or representations, oral or written, express or implied, between the Parties other than as set forth in this Agreement.
